STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND FIFTY-FIVE.

RESOLVES in aid of certain Literary Institutions.

Resolved, That there is appropriated from the
2 proceeds of the sales of the public lands, now in
3 securities in the Land Office of the State and such as
4 may hereafter accrue, the sum of twenty thousand
5 dollars a year, for three successive years, commencing
6 with the year eighteen hundred fifty-five, for the ben-
7 efit of the Literary Institutions herein named, as
8 follows: To Waterville College, located at Waterville,
9 and to the Maine State Seminary, to be hereafter
10 incorporated and located, the annual sum of five
11 thousand dollars each; to the Maine Wesleyan Sem-
12 inary and Female Collegiate Institute, located at
13 Readfield; the East Maine Conference Seminary,

14 located at Bucksport; and to the Westbrook Seminary
15 located at Westbrook, each, the annual sum of three
16 thousand three hundred and thirty-three dollars and
17 one third: *provided*, that each of these Institutions,
18 except the East Maine Conference Seminary, shall
19 raise each year by private subscription, a sum equal
20 to the sum hereby annually appropriated to it.

Resolved, That whenever the Treasurer of either of
2 said Institutions shall file a certificates under oath,
3 with the Governor and Council, that there has been
4 paid into the Treasury of said Institution during
5 either of the years above named, by private subscrip-
6 tion, the sum herein required for that year, said
7 Governor and Council shall cause to be paid from the
8 fund aforesaid, to said Institution—and to said East
9 Maine Conference Seminary without such certificate—
10 the sum herein appropriated to it, and may draw their
11 warrants for the same, and do and cause to be done
12 all that shall be necessary to carry the purposes of
13 these Resolves into full effect.
