STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND FIFTY-SIX.

AN ACT to repeal chapter 489 of the private and special laws, entitled "An Act to re-unite the towns of Anson and North Anson."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. Chapter 489 of the private and special
- 2 laws, approved March 13th, 1855, entitled "an act to
- 3 re-unite the towns of Anson and North Anson," is
- 4 hereby repealed.
- Sect. 2. This act shall take effect from and after 2 its approval by the governor.

STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND FIFTY-SIX.

AN ACT to repeal an act entitled "an act to re-unite the towns of Anson and North Anson."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. The act entitled "an act to re-unite

- 2 the towns of Anson and North Anson," approved
- 3 March 13th, A. D. 1855, is hereby repealed; and the
- 4 towns of Anson and North Anson re-incorporated
- 5 with all the rights, powers, duties and privileges of
- 6 other towns in this state, including within the limits
- 7 of each the same territory they embraced before said
- 8 union.
 - Sect. 2. The town of North Anson, hereby incor-
- 2 porated, shall be holden to pay to the town of Anson,
- 3 hereby incorporated, whatever sums of money the
- 4 town of Anson, as united with North Anson, expended
- 5 during the union of said towns, for the repairs and
- 6 re-building of highways and bridges within the limits

- 7 of North Anson aforesaid, which was collected from
- 8 the inhabitants of that part of said town of Anson
- 9 which comprises under this act the town of Anson.
 - Sect. 3. The taxes already assessed by the town
- 2 of Anson, as incorporated by the act of re-union, ap-
- 3 proved March 13th, 1855, which remain unpellected,
- 4 shall be collected as if this act had not been passed,
- 5 and the money shall be applied, together with any
- 6 money now in the hands of the collector or treasurer,
- 7 to the payment of the debts existing against said town;
- 8 and any surplus remaining shall be paid to the towns
- 9 of Anson and North Anson, as created by this act, in
- 10 proportion to the amounts collected from the inhabi-
- 11 tants of each respectively.
 - Sect. 4. The ministerial and school fund held by
 - 2 the town of Anson shall be divided between the two
 - 3 towns hereby incorporated, in proportion to the num-
 - 4 ber of scholars in each town respectively.
 - Sect. 5. The town houses and other real estate
 - 2 which belonged to the respective towns before their
 - 3 union under the act of March 13th, 1855, shall be
 - 4 the property of each town respectively as if said act
 - 5 of re-union had never been passed.
 - Sect. 6. All paupers shall hereafter be supported

- 2 by the respective towns in the same manner as if the
- 3 act of re-union approved March 13th, 1855, had not
- 4 been passed.
 - Sect. 7. Any justice of the peace for the county
- 2 of Somerset, on the application of five freeholders,
- 3 shall e authorized to issue his warrant for the calling
- 4 of town meetings in each of said towns of Anson and
- 5 North Anson, on giving seven days notice thereof,
- 6 for the choice of town officers, and such other busi-
- 7 ness as is usually transacted by towns.
- Sect. 8. This act shall take effect from and after 2 its approval by the governor.
