## STATE OF MAINE.

## IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY.

AN ACT in addition to an act entitled an act to authorize certain cities and towns to grant aid in the construction and completion of the Kennebec and Portland Railroad, approved April 17, 1850.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Whenever the commissioners of the 2 sinking fund created by the act to which this is addi-3 tional, shall deem it for the interest of the cities and 4 towns, who have loaned their credit respectively to the 5 Kennebec and Portland Railroad Company in aid of 6 the construction of said road, to take the entire pos-7 session of said railroad for the purpose of running and

8 managing the same on account of the breach of any 9 of the conditions of the mortgage of said road, given 10 to secure said cities and towns, as provided in the act 11 to which this is additional, said commissioners shall 12 cause written notice of the breach of the conditions or 13 condition of said mortgage and of the fact that they 14 deem it for the interest of said cities and towns to 15 take possession of and to run said road, to be served 16 upon the selectmen of the several towns and upon the 17 mayors of the several cities who have loaned their 18 credit as aforesaid. And thereupon within thirty days 19 after receiving such notice, the selectmen of said towns 20 and the mayors of said cities shall cause legal meet-21 ings of the legal voters of said cities and towns to be 22 called in the manner provided by law, for the purpose 23 of choosing commissioners to take possession of and 24 manage said railroad. Each town and city that has 25 loaned its credit as aforesaid shall at such meeting 26 elect by ballot one commissioner, and the commission-27 ers so chosen shall constitute a board to take posses-28 sion of and run and manage said railroad and the 29 property covered by said mortgage, and shall have the 30 right so to do if they deem it for the interest of said 31 cities and towns.

### KENNEBEC AND PORT. RAILROAD.

SECT. 2. Said commissioners so chosen shall have all 2 the powers which the trustees of the mortgagees of 3 railroads have now by law when in the actual posses-4 sion of railroads, and be subject to the same liabilities 5 and no more. Said commissioners shall hold their 6 office for one year and until others are chosen in their 7 place.

SECT. 3. Whenever the condition of the mortgage, 2 for the breach of which possession is taken by said 3 commissioners, shall be fulfilled, either by the railroad 4 company or any mortgagee of said company, said com-5 missioners shall surrender the possession of said rail-6 road to such party as by law shall be entitled to take 7 the same.

SECT. 4. This act shall take effect from and after its 2 approval by the governor.
