STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY.

AN ACT additional to incorporate the Proprietors of the Augusta Free Bridge Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. The Augusta Free Bridge Company may 2 purchase the Kennebec bridge, the franchise thereof 3 and real estate and appurtenances used therewith, on 4 terms agreed upon by the parties, or determined by 5 persons selected by them; and if they are unable to 6 agree, the value of the same may be determined by 7 three disinterested appraisers, inhabitants of the county 8 of Kennebec, appointed by a judge of the supreme 9 judicial court, on application of either party, and a

10 hearing thereon. Said appraisers shall be sworn, give 11 notice to the parties of the time and place of their 12 meeting to examine and appraise said property, and 13 make to each party a written award, and their servi-14 ces shall be paid by said free bridge company. The 15 negotiations for this purchase shall be commenced by 16 said free bridge company, by making written applica-17 tion for a sale to the proprietors of the Kennebec 18 bridge, their agent, clerk or treasurer, and said pro-19 prietors shall have thirty days in which to give their 20 answer thereto. If an appraisal is made as aforesaid, 21 said proprietors shall have twenty days after it is made 22 known, to decide whether they will sell thereat. If 23 they decide to do so, and so notify the free bridge 24 company in writing, then said company shall have six 25 months thereafter to pay the appraised value, and if 26 they do so pay, they shall be entitled to a conveyance 27 of the property. If such purchase is effected in either 28 mode, the free bridge company may maintain and 29 operate said bridge, in its present location, under this 30 and the acts to which this is additional. If the pro-31 prietors of the Kennebec bridge do not affirmatively 32 answer in writing the first application of said free 33 bridge company in thirty days, or do not decide to sell 34 at the appraisal and so notify said free bridge company 35 in twenty days, or if after such appraisal, the free

36 bridge company declines to purchase at the appraisal, 37 then said free bridge company may proceed to build a 38 new bridge according to the acts to which this is addi-34 tional.

SEC. 2. The city of Augusta may lay out and estab-2 lish any public ways necessary to connect existing 3 ways in said city with the Kennebec river for the pur-4 poses of erecting said free bridge thereon, subject to 5 the payment of damages as in other like cases.

SEC. 3. The acts to which this additional are modi-2 fied to conform to this act, which shall take effect from 3 and after its approval by the governor.
