STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY.

AN ACT to authorize the city of Augusta to loan its credit in aid of the Augusta Free Bridge Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. The city of Augusta is authorized to issue

- 2 its notes for an amount not exceeding fifteen thousand
- 3 dollars, in sums not less than one hundred dollars each,
- 4 for such time not exceeding ten years and for such
- 5 rate of interest not exceeding six per cent. as may be
- 6 agreed upon when issued, to aid the Augusta Free
- 7 Bridge Company in the erection of a bridge, or the
- 8 purchase of the Kennebec bridge; but this act shall
- 9 not take effect until accepted by said free bridge com-10 pany.

Sect. 2. Before such issue, it is hereby required 2 that the voters of said city shall vote in wards, by 3 ballot, either at their annual meeting on the second 4 Monday of March, or at a meeting which may be 5 specially called for the purpose; and in either case, 6 an article relative thereto shall be inserted in the war-7 rant of the mayor and aldermen calling said meeting; 8 and all in favor of said issue, shall express the same 9 by the word "yes" upon their ballots, and all opposed 10 to said issue shall express the same by the word "no" 11 upon their ballots; and if a majority of those voting 12 upon said question, shall be in favor of said issue, then 13 said city is authorized to issue its notes as aforesaid; 14 and when issued shall state upon their face the purpose 15 for which they were issued, and be signed by the 16 treasurer, and attested by the city clerk, and all bear 17 date when they are delivered. When said notes are 18 delivered, the treasurer shall open an account with said 19 bridge company upon the city leger, charging the 20 same; shall take the receipt of the treasurer therefor, 21 and shall receive from said company certificates of 22 shares in the stock of said free bridge to the amount, 23 at six dollars per share, of four thousand dollars, for 24 every three thousand dollars of said notes so delivered. 25 The city shall retain said shares, until by the sale of 26 the notes of the city, and of the stock of said company

27 and from tolls, the bridge shall be paid for; and then

28 said city may dispose of its stock at the price aforesaid

29 and apply the proceeds to the payment of said notes.

30 Said city shall have a lien on said bridge, its appurte-

31 nances and franchise to secure the final payment of

32 said notes, the interest thereon as it becomes due, and

33 the fulfillment of the bond required, in the following

34 section, to be given by the treasurer of said bridge

35 company to said city.

Sect. 3. After the payment of all bills for the erec-2 tion of a new bridge or the purchase of the Kennebec 3 bridge by said free bridge company, and necessary 4 incidental expenses, the net balance of receipts into 5 the treasury of said company shall be, by the treasurer 6 thereof, paid over monthly to the treasurer of said city; 7 and the treasurer of said company shall render an 8 account to the mayor of said city quarterly, of all re-9 ceipts and expenditures made by him in behalf of said 10 company; and said treasurer shall give bond to said 11 city in the sum of one thousand dollars for the payment 12 thereof. The interest on said notes shall be paid by 13 said city from the moneys received from said company; 14 and the balance, if any, kept or secured by said city on 15 interest, as a sinking fund for the payment of said

16 notes when they shall become due. In case of the 17 failure of said treasurer to pay over as aforesaid, or of 18 his neglect to render his account, or if such receipts 19 are insufficient to pay the interest on said notes as it 20 becomes due, or the principal thereof is not reimbursed 21 to said city, at the maturity thereof, by the sale of the 22 stock held by it, or otherwise by said company, said 23 city is hereby authorized to take possession of said 24 bridge and manage the same in conformity to its 25 charter.

SECT. 4. This act shall take effect and be in force 2 from and after its approval by the governor.
