STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-TWO.

AN ACT in aid of the families of volunteers.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. The cities, towns and plantations in this
- 2 state are hereby severally empowered to raise money
- 3 by taxation or otherwise, to be applied to aid in the
- 4 support of the wife and minor children being inhabit-
- 5 ants of such city, town or plantation, of any soldier,
- 6 who may be actually engaged in the military service
- 7 of the United States, or of this state, in any recognized
- 8 company, battalion, or regiment of this state who shall
- 9 allot or send home from his monthly pay at least the
- 10 sum of eight dollars for the benefit of his family. The

- 11 money so raised to be expended under the direction
- 12 of the municipal authorities of said cities, towns or
- 13 plantations, as the exigencies of the persons for whose
- 14 benefit it was intended may severally require for the
- 15 relief of actual distress.
 - Sect. 2. Of the money so applied by any city, town
 - 2 or plantation, as authorized in section one, there shall
 - 3 be reimbursed from the state treasury to such city,
 - 4 town or plantation, an amount not exceeding seventy-
 - 5 five cents per week for a wife, and fifty cents for each
 - 6 child, being inhabitants as aforesaid, who at the time
 - 7 of such soldier's being called into service were, and
 - 8 who still continue to be dependent on him for their
 - 9 support; provided, however, that the sum so reim-
- 10 bursed shall not in any case exceed ten dollars per
- 11 month for all the persons thus dependent upon one
- 12 soldier.
 - Sect. 3. No such reimbursement shall be made in
 - 2 any case until an account of the expenditures duly
 - 3 certified and sworn to by a majority of the proper
 - 4 municipal authorities, shall be filed with the governor
 - 5 and council, which account shall set forth the name of
 - 6 the soldier for whose family expense has been incurred,
 - 7 also the name of each person who received aid and the
 - 8 sum paid for each of said persons, and that the same

- 9 was necessary to relieve actual distress. Accounts
- 10 thus made out and filed within the time hereinafter
- 11 prescribed, shall be examined by the governor and
- 12 council, and if found correct and duly vouched shall
- 13 be approved.
 - Sect. 4. Such accounts shall be filed with the gov-
 - 2 ernor and council on or before the fifteenth day of
 - 3 January in each year, and shall be passed upon by
 - 4 them on or before the first day of March following.
 - 5 If approved, the amount allowed shall be passed to the
 - 6 credit of the city, town or plantation making the claim,
 - 7 on said first day of March, by the state treasurer, in a
 - 8 book kept for the purpose, and shall draw interest on
 - 9 and after that date. And on said first day of March
- 10 the treasurer shall issue to such city, town or planta-
- 11 tion in his capacity of treasurer, his scrip for the
- 12 amount found due to each, respectively, made payable
- 13 to the order of the treasurer of such city, town or
- 14 plantation, at the state treasurer's office, at the pleas-
- 15 ure of the state, with annual interest.
- SECT. 5. The provisions of this act shall apply to
- 2 expenditures made before its passage, although no
- 3 allotments have been made; and to such expenditures
- 4 as were made (in good faith) and without pauper disa-
- 5 bilities by municipal officers without the sanction of a

- 6 vote of the town, and the time for filing the accounts
- 7 for expenditures made under the sixth section of chap-
- 8 ter sixty-three of the public laws of eighteen hundred
- 9 and sixty-one shall be on or before the first day of
- 10 April eighteen hundred and sixty-two, and the time
- 11 for passing upon such accounts by the governor and
- 12 council, on or before the first day of August eighteen
- 13 hundred and sixty-two, so that the amount allowed in
- 14 each case shall be credited and draw interest on and
- 15 after the date last named. No pauper disabilities shall
- 16 be created by reason of receiving the aid provided for
- 17 in this act.
 - Sect. 6. The word plantation where it occurs in
 - 2 this act is intended to include plantations duly organ-
 - 3 ized for election purposes.
 - Sect. 7. Section sixth of chapter sixty-three of the
 - 2 public laws of eighteen hundred and sixty-one is here-
 - 3 by repealed, and this act shall take effect from and
 - 4 after its approval by the governor.

AMENDMENTS ADOPTED IN SENATE.

Α.

Amend by adding to section seven the following:—

2 And the secretary of state shall furnish an attested

3 copy of this act to the clerks of the several cities,

4 towns and plantations of this state, within thirty days

5 from its approval by the governor.

Amend section five, by striking out the word "April" 2 and inserting "June," and by striking out the word 3 "June" and inserting "August," in said section.

IN SENATE, Feb. 21, 1862.
