STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND
SIXTY-TWO.

AN ACT to amend an act entitled an "Act to authorize
the consolidation of certain roads," passed April first,
eighteen hundred and fifty-six.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows:*

SECTION 1. Section ninth of chapter six hundred and
2 fifty-one, passed April the first, eighteen hundred and
3 fifty-six, is so amended that the same shall read as fol-
4 lows: Should the Penobscot and Kennebec and the
5 Androscoggin and Kennebec railroad companies avail
6 themselves of the provisions of the act passed April
7 first, eighteen hundred and fifty-six, entitled an act to
8 authorize the consolidation of certain railroad compa-
9 nies, and consolidate said companies as therein provid-

10 ed, it shall be done on the condition that said consoli-
11 dated companies shall fix and publish in the Kennebec
12 Journal, printed at Augusta, the time of the crossings
13 of the track of the Somerset and Kennebec Railroad
14 with their daily regular through passenger trains going
15 west and east, and they shall be required to stop at
16 their present station near said crossing, and deliver and
17 receive passengers with their baggage going to and
18 coming from said Somerset and Kennebec Railroad.
19 Should the trains of the Somerset and Kennebec Rail-
20 road company not arrive at said crossing at the times
21 fixed by said consolidated companies for the crossing of
22 their trains, they shall cause their trains to delay and
23 not cross said Somerset and Kennebec road until twen-
24 ty minutes after the time fixed, unless the train of the
25 Somerset and Kennebec Railroad shall have first ar-
26 rived and delivered its passengers with their baggage
27 to said consolidated companies ; and any disagreement
28 arising under this act between the said consolidated
29 companies and the Somerset and Kennebec Railroad
30 company shall be referred to the railroad commission-
31 ers, whose decision in the matter shall be final and
32 binding on both of said parties ; *provided*, that any
33 railroad company, claiming the benefit of this section,
34 shall first accept the provisions thereof as a part of
35 their charter, and make it binding on them.

The ninth section of an act entitled an act to author-
2 ize the consolidation of certain railroad corporations,
3 approved April one, eighteen hundred and fifty-six, is
4 hereby repealed.
