STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-FOUR.

AN ACT relating to the choice and duties of town auditors of accounts.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. Towns at their annual meeting shall
- 2 choose by ballot in the same manner as other officers
- 3 are chosen, three auditors of accounts.
 - Sect. 2. The selectmen, treasurer and every other
- 2 person charged with the expenditure of any moneys of
- 3 the town, shall on or before the fifteenth day of Feb-
- 4 ruary in each year, submit a statement of such ex-
- 5 penditures to said auditors to be by them laid before
- 6 the town, stating therein the amount of such expendi-
- 7 ture, to whom and for what purpose the same was

- 8 paid. Said auditors shall submit their report to the
- 9 town at its annual meeting, which report shall state
- 10 all expenditure of moneys as aforesaid, all claims by
- 11 them allowed and all claims by them rejected. No
- 12 action of said auditors shall bind the town until said
- 13 action is accepted by the town. The compensation of
- 14 said auditors shall be the same as that of selectmen.
 - Sect. 3. In all towns containing one thousand or
 - 2 more inhabitants, said auditors shall at least seven
 - 3 days before the annual meeting, cause a sufficient
 - 4 number, say not less than two hundred copies of said
 - 5 reports to be printed for the use of the town, and to
 - 6 be left at the several post-offices in said town for dis-
 - 7 tribution; and they shall forward one copy thereof to
 - 8 the secretary of state.
 - Sect. 4. This act shall not apply to any incorpo-
 - 2 porated city.
