STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-FOUR.

AN ACT additional to and amendatory of chapter forty of the revised statutes and chapter ninety-nine of the public laws of eighteen hundred and sixty-two, relating to the inspection of fish.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. Chapter forty, section five, of the re-
- 2 vised statutes is hereby amended by striking out all in
- 3 said section after the word "therein," in the thirteenth
- 4 line and inserting, "Mackerel of the best quality, not
- 5 mutilated, measuring not less than thirteen inches from
- 6 the extremity of the head to the crotch or fork of the
- 7 tail, free from rust, taint, or damage, shall be branded
- 8 number one. The next best quality, being not less

- 9 than eleven inches, measuring as aforesaid, free from
- 10 rust, taint, or damage, shall be branded number two.
- 11 Those that remain after the above selections, free from
- 12 taint or damage, and not less than thirteen inches,
- 13 measuring as aforesaid, shall be branded number three
- 14 large. Those of the next inferior quality, free from
- 15 taint or damage, not less than ten inches in length, as
- 16 aforesaid, shall be branded number three. All other
- 17 mackerel free from taint or damage shall be branded
- 18 number three small. The inspectors shall also brand
- 19 in plain letters on the head of every such cask the
- 20 weight, the initials of his christian and the whole of
- 21 his surname, the name of his town, and the letters
- 22 M E, an abridgment of the month, and the year, in
- 23 figures, when packed.
 - SECT. 2. Chapter ninety-nine, section one, of the
 - 2 public laws of eighteen hundred and sixty-two, is
 - 3 hereby amended by striking out the word "two" and
 - 4 inserting "five."
 - Sect. 3. This act shall take effect when approved
 - 2 by the governor.
