#### STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-SIX.

AN ACT for the prevention of the unauthorized use of trade marks and names.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. When a person uses any peculiar name,

- 2 letters, marks, device or figures, cut, stamped, cast
- 3 or engraved upon, or in any manner attached to or
- 4 connected with any article manufactured or sold by
- 5 him to designate it as an article of a peculiar kind,
- 6 character or quality, or as manufactured by him, no
- 7 other person without his consent, shall use the same
- 8 or any similar names, letters, marks, devices or fig-
- 9 ures, for the purpose of falsely representing any arti-
- 10 cle to have been manufactured by, or to be of the same

- 11 kind, character or quality, as that manufactured, or
- 12 sold by, the person rightfully using such name, letters,
- 13 mark, device or figure.
  - Sect. 2. Whoever violates the provisions of the pre-
  - 2 ceding section, or knowingly sells, or exposes for sale,
  - 3 any article having any name, letters, mark, device or
  - 4 figure, attached to, or connected with it, in violation
  - 5 of the preceding section, shall be liable to any party
  - 6 aggrieved thereby for all damages actually incurred,
  - 7 to be recovered in action of tort.
  - Sect. 3. No person carrying on business in this
  - 2 state shall assume or continue to use in his business
  - 3 the name or names of any person formerly connected
  - 4 with him in partnership, or of any other person, either
  - 5 alone or in connection with his own, or any other name
  - 6 or designation, without the consent in writing, of such
  - 7 person, or his legal representative.
  - Sect. 4. The supreme judicial court may restrain
  - 2 by injunction any use of trade marks, or names, in
  - 3 violation of the provisions of this act.
