STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-SEVEN.

AN ACT additional to an act entitled "an act to incorporate the Ticonic Water Power and Manufacturing Company," approved February seven, eighteen hundred and sixty-six.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- SECTION 1. The Ticonic Water Power and Manufac-
- 2 turing Company may purchase and hold estate, real
- 3 and personal to an amount not exceeding in all two
- 4 millions of dollars.
 - Sect. 2. In addition to the dam authorized by the
- 2 original charter, said company may erect and maintain
- 3 on its own land, a dam across the Kennebec river, in
- 4 Waterville and Winslow, at or near the College Rips,

5 so called, and at either or both of said dams may carry
6 on the kinds of business mentioned in said charter;
7 provided they shall at all times maintain and keep in
8 repair in said dams, a safe and convenient sluice for
9 running boards, logs and other lumber down said river;
10 and the damages to any person caused by the flowage
11 of either of said dams, shall be ascertained, secured
12 and recovered in the manner provided in chapter
13 ninety-two of the revised statutes, subject to any alter14 ations of the same that have been or may be made.

Sect. 3. Said company may construct, repair and 2 forever maintain any canals or sluices necessary for the 3 use and development of their water power on either or 4 both sides of the river to draw water therein to propel 5 machinery; the canal on the eastern side to extend 6 from either of said dams southerly not below the mouth 7 of the Sebasticook; and that on the westerly side from 8 either of said dams southerly not below "Leeman's 9 island;" and said company may enter upon, take, 10 hold and use such land as may be necessary for con-11 structing and maintaining the canals and sluices afore-12 said; and the damages to any person for the land so 13 taken and used shall be ascertained, secured, collected 14 and paid in the manner provided in chapter fifty-one 15 of the revised statutes, subject to any alterations

- 16 thereof that have been or may be made; and in case
- 17 of a failure to pay said damages, the owner may main-
- 18 tain an action of trespass, or have any other remedy
- 19 provided in said chapter.
 - SECT. 4. This act shall take effect on its approval 2 by the governor.
