AMENDMENTS offered by Mr. BROWN of Hampden, to bill an act to amend chapter fifty of the public laws of eighteen hundred sixty-six, so as to allow county treasurers a compensation for services rendered under such statute.

A.

Strike out all after the enacting clause and insert the following :

SECTION 1. That chapter fifty of the public laws of
2 eighteen hundred and sixty-six, entitled an act relat-
3 ing to hawkers and pedlers, is hereby amended by
4 adding the following.

SECT. 2. It shall be the duty of the county commis-
2 sioners of the several counties of this state, to furnish
3 the clerks of the several courts with a sufficient num-
4 ber of blank licenses signed by the board or a majority
5 of them, to meet all calls for licenses to peddle under
6 the provisions of this act, which licenses so signed

7 shall be charged to the clerks who shall be held to
8 account for licenses issued once in three months.

SECT. 3. All moneys paid for licenses under this
2 act, shall be received by the clerks of courts who shall
3 pay over to the state treasurer, or deposit in the
4 nearest bank where state funds are deposited, or such
5 other place as may be mutually agreed on between
6 the clerk and treasurer of state, once in three months,
7 except fifty cents for each and every license, taking
8 receipts therefor, which receipts shall be received by
9 the commissioners as payments for licenses signed by
10 them, and all copies found in the hands of clerks at
11 the expiration of three months, together with fifty
12 cents for each license, issued and recorded, shall be
13 credited to such clerk.

SECT. 4. All acts and parts of acts inconsistent with
2 the provisions of this act are hereby repealed.

SECT. 5. This act shall take effect when approved.
