#### STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-SEVEN.

AN ACT to amend chapter one hundred sixty-three of the special laws of eighteen hundred sixty-six, entitled an act to incorporate the Bath Military and Naval Orphan Asylum.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. Section two of said act is hereby
- 2 amended by striking out the word "two" in the first
- 3 line and inserting instead thereof the word "three";
- 4 and by striking out the word "twenty" in the second
- 5 line and inserting instead thereof the word "fifteen";
- 6 and striking out the words "six hundred" in the sixth
- 7 line and inserting instead thereof the words "two
- 8 thousand"; and by striking out in the seventh line

- 9 the following words: "in manner satisfactory to the
- 10 executive"; so that the section when amended shall
- 11 read as follows, viz:
- 12 Scct. 2. If the aforesaid corporators shall within
- 13 three years raise the sum of fifteen thousand dollars,
- 14 and shall exhibit satisfactory evidence to the governor
- 15 and council that the same is duly and permanently
- 16 secured for the purposes named in this act, then the
- 17 governor shall be authorized to draw his warrant on
- 18 the state treasurer for the sum of two thousand dol-
- 19 lars annually, in favor of said corporation, to be by
- 20 them applied to carry out the objects herein named.
  - Sect. 2. Section three of said act is hereby re-2 pealed.
    - Sect. 3. Section four of said act is hereby amended
  - 2 by striking out in third line "four" and inserting
  - 3 instead thereof "three"; so that the section when
  - 4 amended shall read as follows, viz:
    - Sect. 4. There shall be chosen annually for the
  - 2 government of said asylum, seven trustees, three of
  - 3 whom shall be selected by the governor and council.
