STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-SEVEN.

AN ACT to annex the town of Danville to the town of
Auburn.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows :*

SECTION 1. The town of Danville is hereby annexed
2 to, and made part of, the town of Auburn.

SECT. 2. All the liabilities of the town of Danville
2 are hereby assumed by the town of Auburn, except the
3 liabilities, if any, incurred by reason of any vote or
4 votes of said town of Danville, at a meeting held June
5 twenty-second, A. D. eighteen hundred and sixty-
6 three.

SECT. 3. All of the personal and real estate owned

2 by the town of Danville, is hereby conveyed to, and
3 to be owned by, the town of Auburn.

SECT. 4. The collector of taxes of the town of Dan-
2 ville, is hereby authorized and empowered to collect
3 and pay over to the treasurer of the town of Auburn,
4 all taxes he was directed to pay to the treasurer of the
5 town of Danville, now assessed and committed to
6 him for collection, not already collected and paid in to
7 the treasurer of Danville.

SECT. 5. All taxes which have been assessed for the
2 repairs of highways, and committed to highway sur-
3 veyors in the town of Danville, shall be expended and
4 worked out on the highways, under the direction of
5 said surveyors, and return thereof made to the select-
6 men of Auburn.

SECT. 6. The treasurer of the town of Danville shall
2 pay over all moneys, and deliver all books, papers and
3 documents pertaining to his office, to the treasurer of
4 the town of Auburn.

SECT. 7. The town clerk of the town of Danville
2 shall deliver to the town clerk of the town of Auburn,
3 all reports and books belonging to the town of Dan-
4 ville, and all papers, records and documents pertaining
5 to his office. The assessors, selectmen and overseers
6 of the poor of the town of Danville, shall deliver all

7 books, papers and documents pertaining to their sev-
8 eral offices, to the assessors, selectmen and overseers
9 of the poor of the town of Auburn.

SECT. 8. The town of Auburn shall keep two ballot
2 boxes at the gubernatorial election for representative
3 to the state legislature, one exclusively for the voters
4 of what is now the town of Danville, until the next
5 general apportionment.

SECT. 9. Chapter four hundred seventy-six of the
2 laws of eighteen hundred and sixty, being an act to
3 incorporate the Danville Mutual Fire Insurance Com-
4 pany, shall remain in full force after the passage of
5 this act.
