STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-SEVEN.

AN ACT to incorporate the Mousam Manufacturing Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Nathaniel L. Thompson, Joseph Tit-2 comb, Joseph Dane, Charles Thompson, James M. 3 Stone, William L. Thompson, Franklin Thompson and 4 William F. Lord, their associates, successors and 5 assigns, are hereby created a body politic and corpo-6 rate by the name of the Mousam Manufacturing Com-7 pany, with all the rights and privileges and subject to 8 all the duties and liabilities of such corporations as 9 defined by the laws of the state.

SECT. 2. The said corporation is authorized to en-

2 gage in the manufacture in the town of Kennebunk, 3 in the county of York, of brick, flour and meal, and 4 fabrics of cotton, wool, paper, wood, boots and shoes, 5 and iron and steel, and to purchase and hold and use, 6 real and personal estate to the amount of their capital 7 stock, and to sell, lease and convey said estate, and 8 to purchase, erect, maintain, alter and repair, on their 9 own lands in said town, dams, mills, buildings, canals, 10 sluiceways, penstocks, and fixtures suitable for carry-11 ing on the manufactures aforesaid.

SECT. 3. The capital stock of said company shall 2 not be less than one hundred thousand dollars, divided 3 into shares of one hundred dollars each, and may be 4 increased at any time hereafter by a vote of the said 5 company to any sum not exceeding five hundred thou-6 sand dollars.

SECT. 4. The affairs of the said company shall be 2 managed by a board of five directors, and the time 3 and place of holding the annual and other meetings, 4 both of the directors and stockholders, shall be fixed 5 by the by-laws of the company.

SECT. 5. Any one of the persons named in this act 2 may call the first meeting of the corporation, by a 3 written notice given to each of the other persons 4 named herein, seven days at least, before the day 5 specified for said meeting, said notices specifying the

6 time, place and objects for which said meeting shall 7 be called.

SECT. 6. This act shall take effect and be in force 2 from and after its approval by the governor.
