IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND  
SIXTY-SEVEN.

AN ACT for the protection of trout in Grand Lake  
Stream.

---

*Be it enacted by the Senate and House of Representatives  
in Legislature assembled, as follows :*

SECTION 1. No person shall take or destroy in Grand  
2 Lake Stream, any trout, after the first day of Septem-  
3 ber and prior to the first day of January in each year,  
4 under a penalty of ten dollars for each offence.

SECT. 2. Any person who shall knowingly purchase  
2 any trout taken from Grand Lake Stream during the  
3 prohibited season, shall forfeit and pay the sum of  
4 five dollars for each offence.

SECT. 3. The penalty for violation of the first and

2 second sections of this act, may be recovered by com-  
3 plaint or indictment, and shall belong one half to the  
4 person complaining of said offence and one half to the  
5 inhabitants of the county of Washington.

SECT. 4. This act shall take effect when approved  
2 by the governor.

AMENDMENTS PROPOSED BY MR. HOBBS OF YORK.

A.

Amend the title by striking out the words, "in Grand  
2 Lake Stream."

B.

Amend section one, by striking out the words, "in  
2 Grand Lake Stream," and insert instead thereof the  
3 words: in any lake, pond or stream in this state.

C.

Amend section two, by striking out the words,  
2 "Grand Lake Stream," and insert instead thereof the  
3 words: any lake, pond or stream in this state.

D.

Add at the end of section three, the words: all acts  
2 and parts of acts inconsistent with this act are hereby  
3 repealed.
