REPORT.

*To the Honorable Governor and Council of the State of
Maine:*

I hereby submit my Report as Agent for the Passamaquoddy
Tribe of Indians for the year 1890, ending November 30th.

By a resolve of the Legislature of the State of Maine,
March 5, 1889, seven thousand four hundred and forty dol-
lars (\$7,440.00) was appropriated for the benefit of the tribe.
To be used for the following purposes, viz:

POPULATION.

The population of the tribe at the present time is five hundred and twenty-three (523).

The number of deaths during the year was twenty-seven (27).

There has been a great amount of sickness in the tribe during the past year. The dread disease la grippe has left many of the old people in ill health.

ELECTIONS.

At the elections at Peter Dana's Point, September 29th, and Pleasant Point, October 2d, Newell Francis was elected Governor, Joseph Selmore Lieutenant Governor and Newell S. Francis Representative to Maine State Legislature.

LOCKUP.

The Governor and Council have requested me to ask the State Legislature for an appropriation sufficient to build a lockup at Pleasant Point, and pay for the service of a police to protect the village from being disturbed by lawless persons from out of town.

BUILDINGS.

The public buildings at Pleasant Point are in very bad condition.

The church is in a very leaky condition and needs shingling. The school-house needs thorough repair and the hall is almost entirely useless for public meetings.

I would advise an appropriation sufficient to repair these buildings.

SCHOOLS.

The schools have been very ably conducted by the Sisters. There is a marked improvement in the morals and education of the tribe.
