## **ANNUAL REPORT**

*To His Excellency, Llewellyn Powers, Governor, and the Honorable Executive Council:*

GENTLEMEN: Pursuant to the requirements of the Statutes, I have the honor to submit herewith my annual report, giving in detail the financial transactions of the State treasury for the fiscal year ending December 31, 1898.

### **TRUST DEPOSITS.**

The Granite State Provident Association of Manchester, N. H., went into the hands of a receiver on May 1, 1896, and all the securities then on deposit in this office, under chapter 79, Public Laws 1891, have remained intact until September 23, of the past year, when the following described securities were delivered, on order of the Supreme Judicial Court, to Hon. Henry B. Cleaves, Receiver in Maine of the Granite State Provident Association:

The Garfield Mutual Life Insurance Company of Lewiston,  
was thrown into the hands of a receiver on March 5, 1898, and  
all the securities on deposit in this office, consisting of two mort-  
gage deeds covering notes to the amount of \$1,600.00, were  
delivered on order of the court, to Hon. Seth M. Carter, receiver,  
March 11, 1898.

#### BONDED DEBT.

During the past year, \$50,000 were paid toward the liquidation  
of the bonded indebtedness of the State and a like amount was  
paid in the year 1897.

There was also paid during the past year, as interest on the  
bonded debt, the sum of \$73,009.00, and for the year 1897,  
\$74,065.00.

The aggregate sum, therefore, paid during the years 1897-8,  
as interest and toward the liquidation of the bonded debt, was  
\$247,074.00. The bonded indebtedness of the State at the pres-  
ent time is \$2,203,000.00.

#### TEMPORARY LOAN.

On January 1, 1898, a temporary loan of \$200,000 was out-  
standing against the State, of which amount \$100,000 became  
payable April 1, 1898, and the balance falls due the present year.

The receipts not being sufficient to meet the current expenses  
and the loan falling due April 1, 1898, at maturity, it became  
necessary to procure a further temporary loan, and therefore  
one of \$100,000, on three months, at a rate of interest of four  
and three-fourths per cent per annum, was negotiated April 1,

1898, and the funds were used to meet the payment of the \$100,000 falling due on that date.

To meet the demands on the treasury, a further sum of \$50,000, on May 12, 1898, was negotiated, payable in one year and bearing interest at four and one-fourth per cent per annum, payable semi-annually.

The loan of \$100,000 negotiated April 1, 1898, on three months and which became due July 1, 1898, was paid at maturity.

Therefore, the temporary loan outstanding against the State has been reduced in the aggregate \$50,000 in the past year, leaving the sum of \$150,000 now outstanding, \$100,000 of which is the loan negotiated March 2, 1897, and falling due March 2, 1899, and the \$50,000 placed with F. S. Moseley & Company of Boston, Mass., May 12, 1898, and falling due May 12, 1899.

#### REVENUE AND TAXATION.

The total amount of receipts of this office from all sources, during the past year, was \$1,854,304.66, which amount increased by \$152,350.22 cash in the treasury on the first day of January, 1898, shows the available cash for the past year to have been \$2,006,654.88, against which warrants drawn by the governor to the amount of \$1,851,931.15 were paid, leaving a cash balance on hand at the close of the year of \$154,723.73.

The cash balance in the treasury at the close of the fiscal year ending December 31, 1896, was \$203,500.58, and at the close of the year 1897, \$152,350.22.

This shows an increase in the amount of cash balance on hand, at this time, compared with the balance at the close of the year 1897, of \$2,373.51 and a decrease compared with the cash balance at the close of the year 1896, of \$48,776.85. Adding to the latter sum, \$150,000.00, the balance of the temporary loan procured in those years and included in the receipts of the office, and now outstanding, it shows that the expenditures have exceeded the receipts, in the past two years, to the amount of \$198,776.85.

During the past nine years, the following balances have been in the treasury at the close of each year:

On the first day of January of each year, the school fund and mill tax, railroad and telegraph tax and soldiers' pensions, due cities and towns, become payable, and to meet this immediate demand, there should be, in order to avoid the liability of resorting to a temporary loan, a cash balance of \$200,000.00, at the close of each year, to meet the demands on the treasury for the first months of the year.

For the past eight years the legislature has appropriated the following amounts:

As will be seen by the above table, the legislature of 1895 placed the rate of taxation for the year 1895 at two and one-half mills on the dollar of the State valuation, and for the year 1896 at two and one-fourth mills. These rates were found to be insufficient to produce the necessary revenue to meet the obligations of the State, and the legislature of 1897 increased the rate to two and three-fourths mills for the year 1897 and a like rate for the year 1898, with the conviction that this rate would

produce ample receipts with which to meet the current expenditures and to cancel the temporary loan which was then known must be negotiated early in the year 1897.

It is now apparent that this rate will not accomplish that purpose, and the condition of the treasury plainly indicates that if the appropriations for the next two years shall equal in amount the appropriations made for the past two years, it will be necessary for the legislature, in order to save the State treasurer from embarrassment in the management of the financial affairs of the State, to provide additional revenue from other sources, or to increase the rate of taxation.

All taxes assessed against cities, towns and organized plantations for the year 1897, have been paid in full.

STATE HOUSE,  
AUGUSTA, January 27, 1899.

*To His Excellency, the Governor, and the Executive Council of  
the State of Maine:*

The committee appointed under the authority of section 71, chapter 2 of the Revised Statutes, to examine the accounts of the Treasurer of State for the year ending December 31, 1898, would respectfully report that they have carefully examined said accounts and find the same to correspond with the amounts as stated in his report.

The amount of cash on hand at the commencement of the fiscal year, January 1, 1898, was \$152,350.22.

The receipts from various sources for the year 1898, were \$1,854,304.66 making a total of \$2,006,654.88.

The expenditures for the year have been \$1,851,931.15, leaving a balance in the treasury on December 31, 1898, of \$154,723.73.

The bonded indebtedness of the State January 1, 1898, was \$2,253,000, as follows: \$1,984,000, bearing 3 per cent interest; \$150,000, bearing 4 per cent interest; \$118,300, bearing 5 per cent interest and \$700, due October 1, 1889, not presented for payment.

Of the above bonded indebtedness, \$50,000 have been paid during the year 1898, leaving the amount of the same at the beginning of the fiscal year 1899, \$2,203,000.

A temporary loan of \$100,000 was made March 2, 1897, which falls due March 2, 1899. A temporary loan of \$100,000 was made April 1, 1897, for one year, which was paid at maturity, by making another temporary loan of \$100,000, for three months, which was paid at maturity.

May 12th, 1898, a temporary loan of \$50,000 for one year was made; so that in addition to the above bonded indebtedness of \$2,203,000, there is an outstanding temporary loan of \$150,000, of which amount, \$100,000 bears  $3\frac{1}{4}$  per cent interest and \$50,000,  $4\frac{1}{4}$  per cent interest.

The committee, in the presence of the State Treasurer, F. M. Simpson, destroyed, by burning, four notes of \$25,000 each, representing the temporary loan of April 1, 1897, and one note of \$100,000, representing the temporary loan of April 1, 1898, together with registered bond No. 424 for \$5,000; registered bond No. 471, for \$28,000; registered bond No. 472 for \$17,000, and coupons to the amount of \$444, paid during the last year; and have certified to the amount of each of said notes, bonds, and coupons destroyed.

The committee have verified all trust deposits, a list of which appears in the treasurer's report.

The committee in making the examination, received valuable assistance from the State Treasurer and his efficient clerks.
