**SUBJECT:** Report on Central Service Savings

---

Public Law 2011, chapter 380, Part R authorized the transfer of savings in the procurement of goods and services from improvements in contracting with vendors and the use of procurement cards. Our efforts in this area were delayed while we worked to address the distribution of several other savings initiatives impacting personnel costs, advertising and technology, and also as a result of our involvement with the Streamlining and Core Government Services Task Force and the supplemental budget to address the MaineCare shortfall. At this time I am reporting on the transfer of savings in the following areas:

- ***Re-competition of "Coarse Paper" (toilet paper, tissue, towel) Contracts***  
The Division of Purchases worked with the Division of Central Services / Central Warehouse to release their statewide "coarse paper" contract for competition, resulting in discounts for the materials (such as toilet paper, tissue, and towel) found in agency facilities across the State. The "discounts" are relative to the price previously paid for these materials. This action results in General Fund savings of \$23,207 in fiscal year 2011-12 and in fiscal year 2012-13.
  
- ***Direct Office/Copy Paper Purchasing (vs. Central Warehouse delivery)***  
The Division of Purchases worked with the Division of Central Services / Central Warehouse to analyze data comparing the delivered price of office/copy paper between the Central Warehouse and a third-party vendor. The vendor was already under contract with the State to provide office supplies and office/copy paper, and to do so on a next-day-delivery basis. From a pricing perspective, it was found to be more advantageous for State agencies to purchase office/copy paper from the vendor, rather than source it from the State's Central Warehouse. This action results in General Fund savings of \$37,015 in fiscal year 2011-12 and in fiscal year 2012-13.

- ***Re-competition of Statewide Printer Lease Agreement***  
The Division of Purchases worked with the Central Printing Office to release their statewide printer lease agreement for competition, resulting in discounts for the office equipment (such as multifunction copying machines) that is found in agency offices across the State. The “discounts” are relative to the price previously paid for the lease of this equipment. This action results in General Fund savings of \$155,275 in fiscal year 2011-12 and \$156,211 in fiscal year 2012-13.
  
- ***Re-negotiated Labor Rates for Corrections' "CORIS" IT System***  
The implementation of the temporary IT services contract has allowed the Division of Purchases to better understand the IT labor market, and work with agencies to re-negotiate other IT contracts that fall outside of the temporary IT services contract. The Division of Purchases worked with the Department of Corrections to receive a discounted price on their IT contract for the CORIS offender management system. This action results in General Fund savings of \$10,000 in fiscal year 2011-12.

The Bureau of Purchases is continuing their review of contracts. As soon as we have confirmed and implemented the results of their analysis from a budget perspective I will submit another report that includes the final transferred amounts.
