Dear Col. Wilkinson,

Again this year, July1, 2011 through June 30, 2012, the ATV Law Enforcement Grant Program has been a very popular program with state, county, and local police agencies. The program has supplied agencies with much needed funds with which to help police the ATV community and thereby help reduce the number of citizen complaints regarding illegal ATV activities. The funds from this program are dedicated strictly to ATV law enforcement, training and equipment needed to work ATV law enforcement.

During fiscal year 2011-2012 the ATV Law Enforcement Grant Program received 67 grant requests totaling \$441,770.64. The ATV Law Enforcement Grant Committee approved \$199,870.04 in grants of which \$155,365.63 was actually used by the requesting agencies. These expenditures accounted for 3003 man hours dedicated strictly to ATV law enforcement. From this effort 210 citations were issued, 456 warnings issued, and 4494 ATVs checked by law enforcement officers.

Since the spring of 2006, this program has received grant requests totaling \$2,724,855.26. The ATV Law Enforcement Grant Committee has approved \$1,339,036.01 in grants with \$947,917.27 of these funds being used and reimbursed to the participating agencies. As a result of these expenditures, 21,974 man hours have been dedicated to ATV law enforcement, 1,816 citations have been issued, 3,608 warnings issued, and 31,638 ATVs checked by law enforcement officers.
