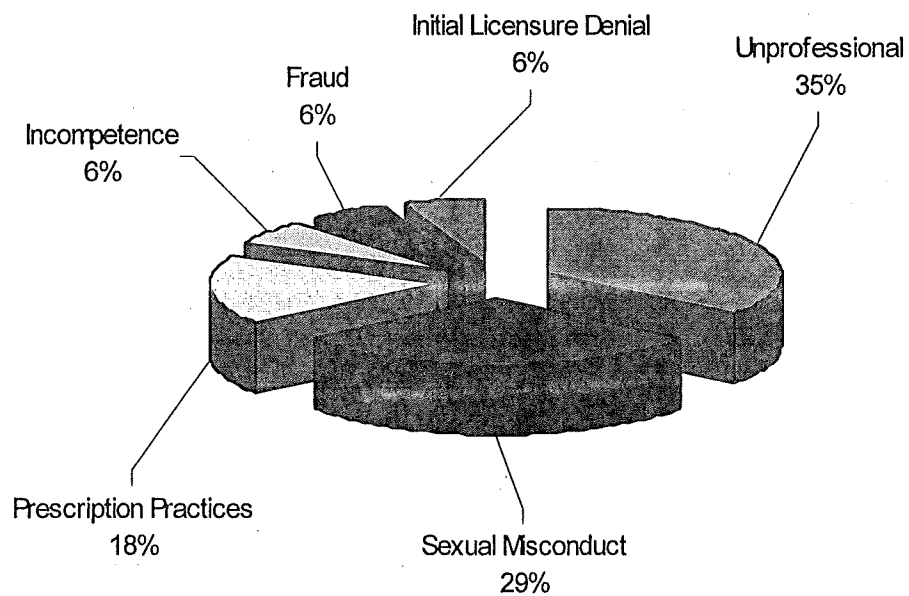

Disciplines in 2000



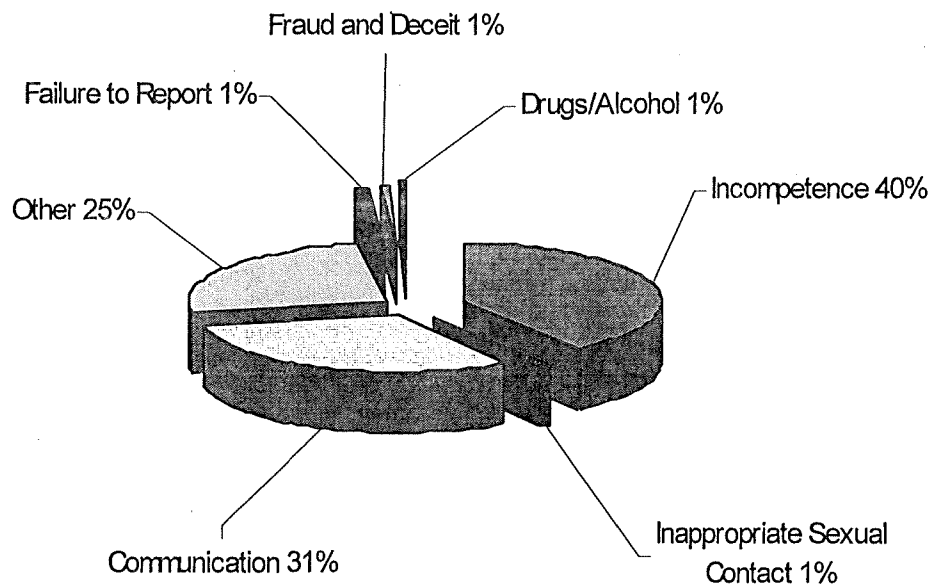
