Number of Complaints carried forward from 2015	58
Number of New Complaints filed in 2016	<u>172</u>
Total Number of Complaints 2016	230
Number of Complaints dismissed in 2016	122
Number of complaints resulting in discipline in 2016	26
Number of Complaints carried forward to 2017	82
Total disciplinary actions 2016	31

We are also required to submit the number of physician disciplinary actions tabulated by the Federation of State Medical Boards (FSMB). This year they tabulated 31 actions. The FSMB system tabulates a reduction in discipline as a new action and breaks some disciplines into multiple reports which makes reconciliation with Board actions very complicated.
