- 85 AN ACT TO REDUCE THE AMOUNT MUNICIPALITIES OUTSIDE THE MAINE FORESTRY DISTRICT MUST PAY FOR CONTROLLING AND EXTINGUISHING FOREST FIRES Violette LV/WD
- SUMMARY: Incorporated into LD 1781.
- 88 AN ACT TO EXEMPT HISTORICAL SOCIETIES AND MUSEUMS FROM STATE SALES TAX Twitchell LV/WD
- SUMMARY: Incorporated into LD 1766.
- 92 AN ACT CONCERNING RETROACTIVE APPLICATION OF THE INCOME TAX INDEXING LAW Tuttle LV/WD
- SUMMARY: Would change effective date from 1981 to 1983 tax years.
- 96 AN ACT TO REMOVE THE RETROACTIVE PROVISIONS OF THE INCOME TAX INDEXING LAW McBreairty ENACT. PL 3
- SUMMARY: Raised taxes for 1981 and 1982 to amount that was due for those years without indexing. Reinstated 1981 tax table for purposes of 1983 indexing. Same effect as repeal of retroactivity.
- 110 AN ACT TO PROVIDE A SALES TAX, TRADE-IN CREDIT FOR LOADERS AND CHAIN SAWS USED TO HARVEST LUMBER Dexter LV/WD
- SUMMARY: Incorporated into LD 1766.
- 114 AN ACT TO PROVIDE FOR TAX CREDITS FOR REFUNDS DUE IN TAX YEARS 1981 AND 1982 UNDER TAX INDEXING Webster ONTP
- SUMMARY: Would provide for credit-refunds of amounts retroactively owed. See LD 96.
- 120 AN ACT TO REQUIRE PUBLIC INSTITUTIONS TO PAY SALES TAX ON INCOME RECEIVED FROM THE RENTAL OF ROOMS FOR MEETINGS Webster LV/WD
- 124 AN ACT TO ADDRESS DEFICITS IMPOSED BY TAX INDEXING Andrews ONTP
- SUMMARY: 16% income tax surcharge to collect amounts retroactively owed. See LD 96.
