LD TITLE SPONSOR DISPOSITION
43 AN ACT TO ESTABLISH THE UNIFORM DE-Soule PL 1983, c. 33
TERMINATION OF DEATH ACT

SUMMARY: Establishes uniform criteria for making a legal determination of when death has occurred. An individual is dead when he has sustained (1) irreversible cessation of circulatory and respiratory functions, or (2) irreversible cessation of all functions of the entire brain, including the brain stem.

115 AN ACT RELATING TO ABORTION BY Martin, A. LV/WD SALINE INJECTION

SUMMARY: Sought to make the performance of a saline abortion on a woman at any stage of pregnancy, except to save the woman's life or to preserve her health, a Class D crime.

148 AN ACT TO MAKE POSSESSION OF Lewis ONTP
MARIJUANA A CRIMINAL OFFENSE

SUMMARY: Sought to make knowing or intentional possession of 1 1/2 ounces or less of what the person knows or believes to be marijuana, and which is, in fact, marijuana a crime. The penalty for a first conviction would have been a fine of at least \$50 and not more than \$200; for a second conviction a fine of at least \$100 and not more than \$500, or up to 30 days imprisonment, or both; and for a third or subsequent conviction, a fine of at least \$150 and not more than \$1,000, or up to 6 months imprisonment, or both. Current law provides that possession of a useable amount of marijuana is a civil violation, with not more than a \$200 penalty. However, knowing or intentional possession of more than 1 1/2 ounces of marijuana creates, under current law, a presumption of the crime of unlawfully furnishing scheduled drugs.

PENOBSCOT LAW ENFORCEMENT
OFFICERS

SUMMARY: Extends the powers, duties, and training requirements of State Game Wardens to Penobscot and Passamaquoddy Wardens.
