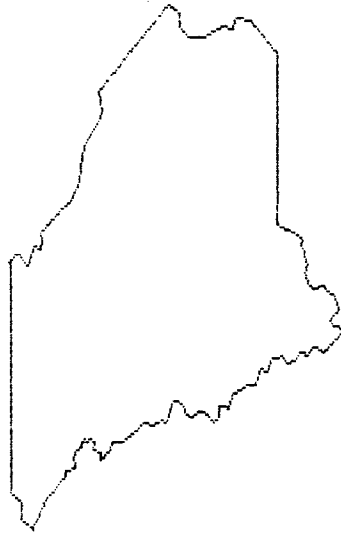

SUMMARY: Increases a number of small fees assessed for filing of documents with the Secretary of State under the UCC. Funds that would be generated would inure to the General Fund.

SUMMARY: Updates criminal penalty to be Class E crime; requires reapplication when agency has change in ownership; allows Superintendent of Consumer Credit Protection to bring action for civil penalty; strikes unconstitutional requirement that agency maintain place of business in the State.

SUMMARY: Requires owners of vehicles to carry liability insurance with certain limits; proof of compliance required at registration, and as provided under the proof of financial responsibility law; penalty for operating without insurance would be civil violation with fine up to \$100 and suspension of right to operate for 3 months.

SUMMARY: Requires owners of vehicles to carry liability insurance with certain limits; proof of compliance required at registration, and as provided under the proof of financial responsibility law; penalty for operating without insurance is Class E crime, indefinite suspension.
