C.22 181 AN ACT CONCERNING THE MARKING OF WILD BIRDS SUMMARY: This bill changes the type of marking for wild birds. rather than seals will be the method required and these will metallic. Ringneck pheasants are the only pheasants that will require a legband. Lewis ENACT. C.215 198 AN ACT TO PROHIBIT SHOOTING WITHIN 100 YARDS OF ANY DWELLING DURING HUNTING SEASON SUMMARY:

SUMMARY: This Act extends the limitation for discharging a firearm near a dwelling from 100 feet to 100 yards. An exception for killing or taking a wild animal in accord with sections 7501 and 7502 (nuisance animals and animals destroying crops) is included.

199 AN ACT TO REQUIRE PERSONS Jacques ENACT. C. 270
BEING LICENSED TO HUNT FOR
THE FIRST TIME TO HAVE COMPLETED A GUN SAFETY COURSE

SUMMARY: This act requires any person who applies for a license to hunt with firearms (other than a juvenile license) to show proof of having completed a hunter safety course or of having had a license in any year beginning in 1976. A signed affadavit may be substituted if evidence is not available.
