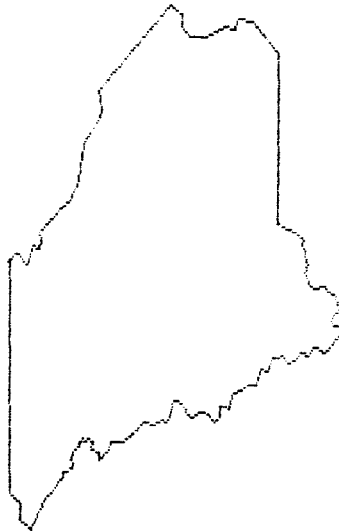

SUMMARY: This bill changes the type of marking for wild birds. Leg bands rather than seals will be the method required and these will be metallic. Ringneck pheasants are the only pheasants that will require a legband.

SUMMARY: This Act extends the limitation for discharging a firearm near a dwelling from 100 feet to 100 yards. An exception for killing or taking a wild animal in accord with sections 7501 and 7502 (nuisance animals and animals destroying crops) is included.

SUMMARY: This act requires any person who applies for a license to hunt with firearms (other than a juvenile license) to show proof of having completed a hunter safety course or of having had a license in any year beginning in 1976. A signed affidavit may be substituted if evidence is not available.
