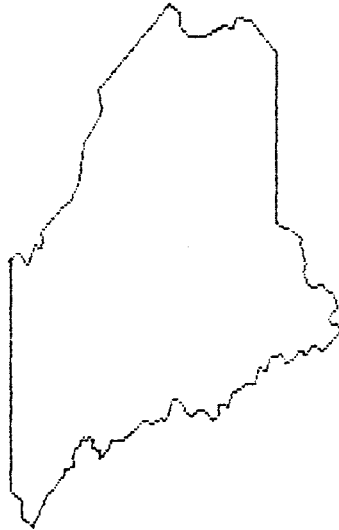

218	AN ACT TO MAKE MORE EFFICIENT THE ENFORCEMENT OF LAWS RELATING TO CRUELTY TO ANIMALS	Wood	OTP IN NEW DRAFT, NEW TITLE, ID 1530 ENACTED PL 308
<p>SUMMARY: Establishes administrative authority for an animal welfare board within the Department of Agriculture which has responsibility for dog licensing, kennel inspections, and enforcement of cruelty to animal laws. The animal welfare board consists of ten (10) members, including 4 members representing agriculture and 4 members representing humane societies.</p>

<p>SUMMARY: Authorizes licensed beekeepers to obtain a permit from the Commissioner of Inland Fisheries and Wildlife to protect hives from damage from bears. House Amendment "A" changed the title to eliminate the word "compensation".</p>
