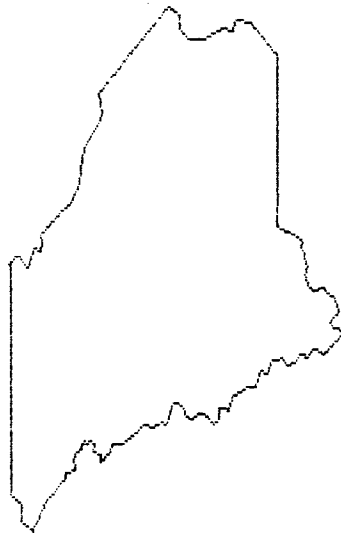

SUMMARY: Amends the Used Car Information Act to require disclosure that a vehicle was returned for nonconformities to express warranties, e.g., pursuant to a "lemon law."

COMMITTEE AMENDMENT "A" (H-184): Adds language to bill to clarify the remedy available in a private action, and makes violation of the Used Car Information Act a civil violation, punishable by a fine of up to \$1000.
