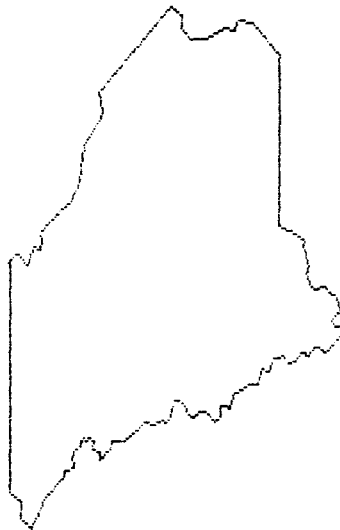

394 AN ACT TO INSURE NOTICE DEFENSE IS Martin,J. LV/WD(acc.)  
BASED ON PREJUDICE TO THE EMPLOYER Tuttle  
Tammaro  
Norton

SUMMARY: Employee's failure to provide notice of injury shall not bar his claim to compensation unless the employer can prove his rights were prejudiced by that failure.

395 AN ACT TO REQUIRE WORKERS' COMPEN- Beaulieu LV/WD(acc.)  
SATION COMMISSIONERS TO EXPLAIN Tammaro  
FULLY THE REASONS FOR THEIR DECI- Norton  
SIONS

SUMMARY: Workers' Compensation Commission must issue full written findings of fact and rulings of law in each decision rather than a summary decision as allowed under the current law.

396 AN ACT TO MAKE THE DEFINITION OF A Gauvreau LV/WD(acc.)  
MUNICIPAL PUBLIC EMPLOYEE CONSIS- Brannigan  
TENT WITH THE DEFINITION OF A STATE  
EMPLOYEE FOR PURPOSES OF COLLECTIVE  
BARGAINING

SUMMARY: Amends definition of employee under Municipal Public Employees Labor Relations Act to conform to the definition in the State Employees Labor Relations Act; it excludes those who have policy making roles, are involved in collective bargaining, and who are attorneys for the State.

397 AN ACT TO AMEND TEMPORARILY THE Beaulieu OTP  
BENEFIT FINANCING PROVISIONS OF THE PL 1983, c. 16  
EMPLOYMENT SECURITY LAW (emerg.)

SUMMARY: Reduces tax burden on employers in 1983 by replacing the reduction in federal unemployment tax credits with increase in wage contributions; part of the increased tax liability is thereby shifted to 1984, after which federal loans will be repaid in full and the tax credit restored.

445 AN ACT TO ALLOW EVIDENCE AND TESTI- Hayes LV/WD(acc.)  
MONY FROM VOCATIONAL EXPERTS Norton  
Tuttle

SUMMARY: Workers' Compensation Commissioners would be required to accept reports from vocational experts as evidence on employability.

446 AN ACT TO REPEAL THE NONNEGOTIA- Dutremble LV/WD(acc.)  
BILITY OF CERTAIN EDUCATIONAL  
POLICIES

SUMMARY: Would allow public school teachers to negotiate with school administrators on educational policies.
