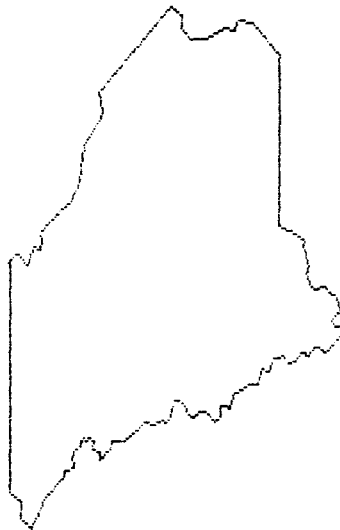

447 AN ACT TO PROVIDE ADEQUATE NOTICE Usher LV/WD(acc.)  
OF JOB REFERRALS IN THE UNEMPLOY- Michaud  
MENT INSURANCE PROGRAM

SUMMARY: No claimant may be disqualified for refusal to accept a referral to a suitable job opportunity unless it is made in writing with a finding of suitability and a written statement of the penalty for failure to report to the referral.

NOTE: Before bill was withdrawn, the matter was referred to the Dept. of Labor Advisory Council.

SUMMARY: Intended to establish a minimum wage at 3/4 of the prevailing minimum wage; as written, would have decreased the amounts paid to service employees.

COMMITTEE AMENDMENT "A" (H-38): gradually decreases allowable tip credit to bring the minimum wage for service employees in line with the federal minimum for service employees of larger employers.
