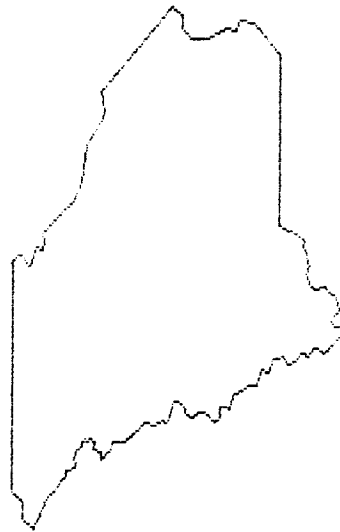

402 AN ACT RELATING TO THE FREQUENCY OF Manning ONTP  
PAYMENTS BY CERTAIN COUNTY OFFICIALS  
TO COUNTY TREASURERS

SUMMARY: Sought to permit registers of deeds to account for and pay over to county treasurers fees received by the registry on a weekly basis. Current law states that these fees shall be accounted for monthly.

450 RESOLVE, TO AUTHORIZE THE COMMIS- Usher RESOLVE 1983,C.3  
SIONERS OF CUMBERLAND COUNTY TO RE-  
IMBURSE THE TOWN OF STANDISH \$4,620.21  
UNEXPENDED RETIREMENT FUNDS

SUMMARY: Standish has contracted for police protection with Cumberland County over the past several years. As a part of the contract price, Standish has paid the employer retirement costs for the personnel assigned to assist Standish. In 1979 and 1980, Standish paid retirement costs for a deputy when, unknown to them, the deputy was not participating in the retirement system. This Resolve authorizes the county to reimburse Standish for those costs.

526 RESOLVE, TO NAME THE BROCK AND POND Twitchell RESOLVE 1983, C.2  
LOCATED ON THE WEST POLAND ROAD IN  
OXFORD COUNTY AND ON THE WEST SHORE  
OF THOMPSON LAKE IN HONOR OF THE  
PERKINS FAMILY

SUMMARY: Changes Frog Pond to Perkins Pond and names the unnamed brook between Frog Pond and Thompson Lake as Perkins Brook.

527 AN ACT TO PROVIDE ALL MUNICIPALI- Perkins,T. PL 1983, C.58  
TIES WITH THE OPTION TO ESTABLISH  
A LOCAL BOARD OF ASSESSMENT REVIEW

SUMMARY: Municipalities with one assessor have the option of establishing a local board of assessment review to hear assessment appeals. Appeals from municipalities with 3, 5, or 7 assessors must be brought before the county commissioners. This allows all municipalities the option of establishing a local board of assessment review.

566 AN ACT REGARDING THE RECORDING OF Armstrong PL 1983, C.15  
INSTRUMENTS IN THE DAY BOOK OF THE  
REGISTRY OF DEEDS (NEW DRAFT ID125)

SUMMARY: Eliminates some of the information register of deeds had to record in a day book when an instrument conveying property was filed in the registry. Now the register must only place in the day book the names of the grantor and grantee, the place where the property conveyed is located, and the time of filing.
