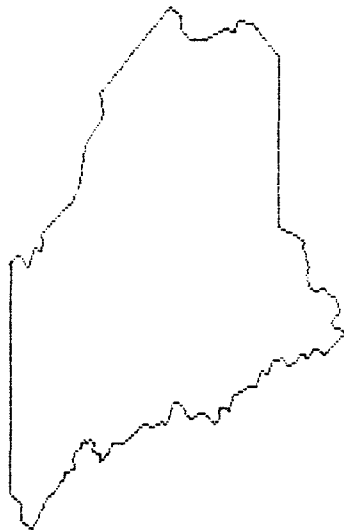

- 511 AN ACT TO IMPROVE THE IDENTIFICATION OF PERSONS TRYING TO EVADE STATE TAXES McHenry OTP-ND-LD1745
- SUMMARY: Original bill established toll free telephone number, confidentiality and reward for reports of evasion of any tax owed to the state. See LD1745.
- 512 RESOLVE, AUTHORIZING THE STATE TAX ASSESSOR TO CONVEY THE INTEREST OF THE STATE IN CERTAIN REAL ESTATE IN THE UNORGANIZED TERRITORY Vose PASSED-RESOLVE 5
- 514 AN ACT TO ESTABLISH A MEALS AND LODGING TAX Kane LV/WD
- SUMMARY: 2% local option.
- 515 AN ACT TO PROVIDE A SALES TAX EXEMPTION FOR SALES TO CERTAIN HUMANE SOCIETIES Livesay LV/WD
