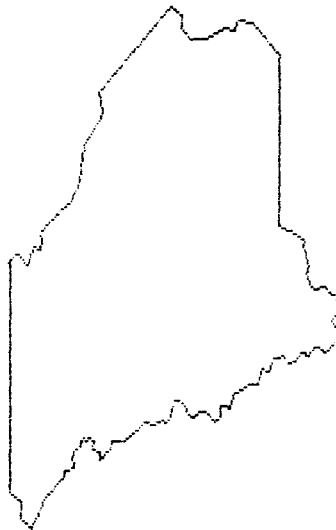

600 AN ACT TO PERMIT CERTAIN SMALL BUSINESSES TO EXEMPT THEMSELVES FROM THE WORKERS' COMPENSATION LAW

SUMMARY: Same as LD 74, except adds requirement that employer provide minimum of \$25,000 worth of medical payment insurance for each employee.

SUMMARY: Increases penalties under unemployment laws from Class E to Class D crimes for making false statements, refusing to furnish information or make payments, or other violations.

COMMITTEE AMENDMENT "A" (H-67): Making false statements and refusing to furnish information or make payments are Class D crimes but other offenses under the unemployment laws are left as Class E crimes. (adopted).
