- 616 AN ACT TO AMEND THE FARM AND OPEN SPACE TAX LAW RECAPTURE PENALTY Wood LV/WD
 SUMMARY: Would reduce withdrawal penalty to 10%. See LD 859.
- 617 AN ACT TO PROVIDE SALES TAX CREDIT ON STOLEN VEHICLES Carpenter LV/WD
- 636 AN ACT TO AMEND THE FOREST FIRE CONTROL LAWS AND CHANGE THE METHOD OF FUNDING FOREST FIRE CONTROL SERVICES MAJ-OTP-ND-LD1781
 MIN-ONTP
 SUMMARY: Minority report of Maine Forest Fire Control Study Commission. Original bill recommends suppression costs funded by tax on 100 acre + parcels. See LD 1781.

 SUMMARY: Majority report of Maine Forest Fire Control Study Commission - recommends 100% General Fund funding. See LD 1781.

 SUMMARY: Recommendation of Committee Study. Committee amendment provides for two questions on the ballot: 1) exempting minerals from consideration in calculating current use valuation withdrawal penalties and removing minerals from the municipal reimbursement requirement and permitting more than 50% reimbursement, and 2) requiring a two-thirds vote of the Legislature for expenditure of funds from the Mining Excise Tax Trust Fund. These questions will be submitted to the People in November.

 SUMMARY: MED repealed. See LD 1781.
