573 AN ACT TO INCLUDE WATER AND SEWER DISTRICTS IN THE LOCAL GOVERNMENT ENERGY CONSERVATION PROGRAM McGowan PL 1983, c. 24

SUMMARY: Makes buildings owned by water or sewer districts eligible for 50/50 matching funds for energy conservation improvements under the Local Government Energy Conservation Program. These buildings were not included in the definition of "local government buildings," when the program was established in 1979.

574 AN ACT TO AMEND THE HAZARDOUS WASTE STATUTES ADMINISTERED BY THE DEPARTMENT OF ENVIRONMENTAL PROTECTION Mitchell, J PL 1983, c. 432

SUMMARY: Makes minor technical changes to hazardous waste statutes.

575 AN ACT TO MAKE ALLOCATIONS FROM THE MAINE NUCLEAR EMERGENCY PLANNING FUND FOR THE FISCAL YEARS ENDING JUNE 30, 1984, AND JUNE 30, 1985 (emergency) Mayo PL 1983, c. 30

SUMMARY: Makes allocations from the Maine Nuclear Emergency Planning Fund to enable the department to meet expenses due July 1, 1983.

576 AN ACT TO MAKE ALLOCATIONS FROM THE MAINE HAZARDOUS WASTE FUND FOR THE FISCAL YEARS ENDING JUNE 30, 1984, AND JUNE 30, 1985 (emergency) Jacques PL 1983, c. 395

SUMMARY: Makes allocations from the Maine Hazardous Waste Fund to enable the department to meet expenses due July 1, 1983. The bill also transfers General Fund revenues from licensing hazardous waste transporters to the Hazardous Waste Fund.
