761 AN ACT TO INCLUDE SALARIES, PENSIONS Jalbert LV/WD(acc.)  
AND INSURANCE FOR BINDING ARBITRATION Beaulieu  
UNDER THE MUNICIPAL PUBLIC EMPLOYEES  
LABOR RELATIONS LAW

SUMMARY: Salaries, pensions and insurance are made items subject to binding arbitration.

783 AN ACT RELATING TO ATTORNEY'S FEES Bell LV/WD(acc.)  
UNDER THE WORKERS' COMPENSATION LAW Zirkilton  
Willey

SUMMARY: Attorney's fees would be paid for the claimant in a workers' compensation case only if he or she prevails in the claim.

SUMMARY: Permits negotiation of union security provisions into collective bargaining agreements for municipal public employees.

SENATE AMENDMENT "A" (S-45): Restricts authority of arbitrators to insert union security provisions into collective bargaining agreements between municipal and school employers and their employees (Sewall).

HOUSE AMENDMENT "A" (H-123): same as Senate Amendment (Zirkilton).

SUMMARY: Increases pre-decree workers' compensation interest from 6% to 10% and post-decree interest from 10% to 16%.
