SUMMARY: Exempts signs for seasonal lobster pounds from all licensing or other requirements of the billboard law.

SUMMARY: Removes the prohibition on directional signs being placed on the same highway on which the business is located.

SUMMARY: Extends the distance from the business in which a directional sign may be placed from 10 miles to 25 miles; requires action on an application within 30 days after receipt of the application.

SUMMARY: Would allow a municipality to approve erection of a business directional sign on the same highway as the business, within 2 miles, if the speed limit on that portion of the highway is 45 mph or more.
