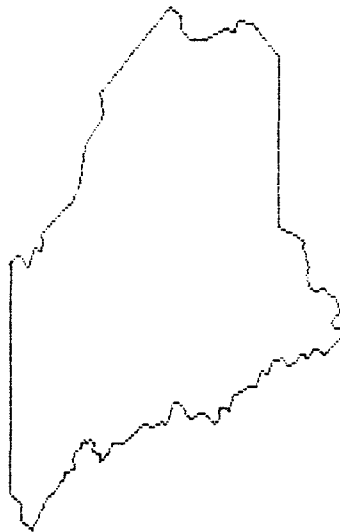

- 862 RESOLUTION, PROPOSING AN AMENDMENT Kane OTP-ND-LD1349  
TO THE CONSTITUTION OF MAINE TO  
PROVIDE THAT THE STATE MAY ENACT  
PROPERTY TAX EXEMPTIONS NOT SUBJECT  
TO FIFTY PERCENT REIMBURSEMENT

- SUMMARY: Time share estates separately taxable. Municipal notice  
fee increased to cover additional municipal costs. Require escrow if  
managing entity collects taxes from time-share owners.
