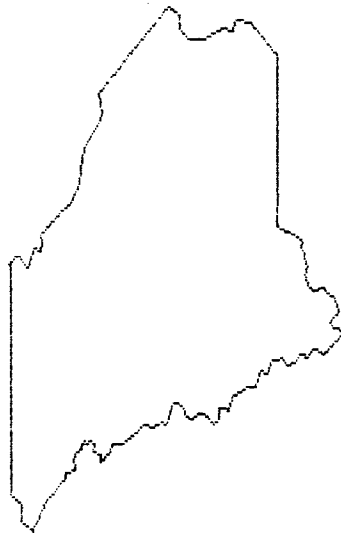

461	AN ACT CONCERNING TELEVISION RECEIVING EQUIPMENT	BAKER HIGGINS, L	ONTP

SUMMARY: Governs warranties on televisions, radios and other audio-visual equipment; requires fair reimbursement to repair technicians; requires adequate supplies and service information; requires maintenance of in-state repair facilities.

462	AN ACT TO PROHIBIT THE COMMERCIAL SALE OF CHAIN SAWS AND SKIDDERS NOT EQUIPPED WITH SPARK ARRESTERS	KEISMAN REDMOND MASTERMAN MCBREIARTY	(OTPA) PL1983,c.104

SUMMARY: Prohibits commercial sale of chain saws and skidders without spark arrestors, due to fire hazard.

COMMITTEE AMENDMENT "A" (H-61): Limits bill to skidders only. (S. Adopted; H. Indef. postponed; bill passed without C "A")

SUMMARY: Prohibits use of video equipment, facilities and personnel of MPBN and public schools, VTI's, etc. from being used in competition with private video enterprises.

SUMMARY: Seeks to allow recovery of damages in a claim for an unfair trade practice.

<b>898</b>	AN ACT TO REQUIRE MANUFACTURERS SELLING WARRANTED PRODUCTS IN MAINE TO MAINTAIN IN-STATE REPAIR FACILITIES	MINKOWSKY MELENDY HAYES CROWLEY	LV/WD

SUMMARY: Governs warranties on consumer products costing \$100 or more; requires in-state service facilities, reasonable reimbursement for warranty work, adequate supplies of parts and service information, deadlines for extended repair periods, and remedies, including price reductions and unfair trade practice.
