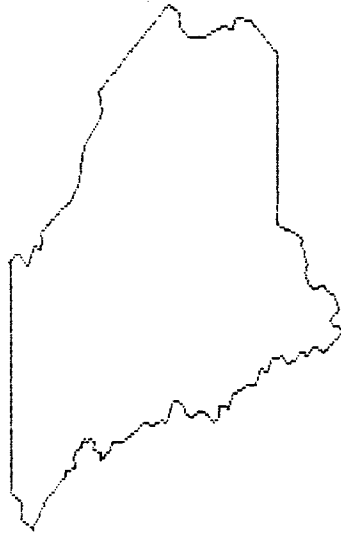

OCCUPATIONAL LICENSING

Barbers & Cosmetologists

352	AN ACT TO PERMIT BARBERS TO CUT HAIR OUTSIDE OF BARBER SHOPS	DEXTER	(OTPA-9) (ONTP-4) PL 1983, c.339

SUMMARY: Allows barbers, like cosmetologists, to practice the trade upon a person in the person's residence.

COMMITTEE AMENDMENT "A" (H-215): Requires that in order to practice at persons' homes, the barber must maintain or be employed in a licensed shop; allows board to prescribe rules for the practice in homes. (ADOPTED)

SUMMARY: Provides for the replacement of one of the industry members on the Board of Barbers by an owner of a certified school of barbering.

SUMMARY: Transfers jurisdiction over barbering and cosmetology schools from the respective licensing boards to the Department of Educational and Cultural Services.

SUMMARY: Requires certification and licensure of blasters by the Commissioner of Public Safety; qualifications would be determined by rule of the commissioner, with advice of the State Fire Marshal.
