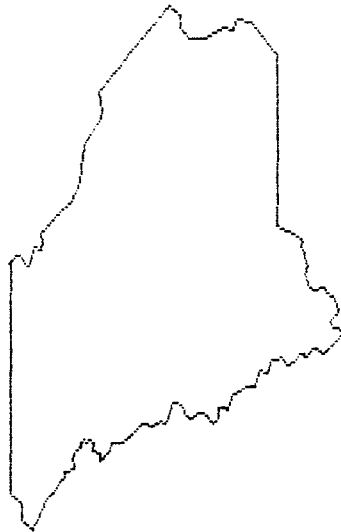

SUMMARY: The referendum method of voting on SAD school budgets as originally passed had a sunset provision to terminate the option on January 1, 1983. A bill extending the option to all SAD's passed last session, but inadvertently failed to remove the sunset provision.

SUMMARY: The bill clarifies the procedures pertaining to desolution and withdrawal from an SAD or CSD. It (1) specifies that the amount of money to be spent by the desolution committee be included on the warrant, (2) specifies that one member of the group filing the petition be on the desolution committee, (3) clarifies certain procedural points and (4) specifies that a new petition may not be filed for 2 years if the municipal vote on the petition received less than 60% of the vote or if the district rate on the desolution agreement received less than 45% of the vote.
