SUMMARY: Authorizes Coffren to bring civil action against State for property damage caused by former inmates of state institutions due to alleged negligence of State; possible recovery of up to \$50,000.

SUMMARY: Any State Police regulation on beano prizes must include provisions that no single prize may exceed \$300 in value and that no more than \$1,000 in total prizes may be awarded on any one occasion. Withdrawn after receipt of letter from State Police Chief stating that rules will be promulgated allowing up to \$250 per single prize and \$1,200 maximum per occasion.

SUMMARY: Increases license fees for private investigators and security guards.

COMMITTEE AMENDMENT "A" (H-128): adds provision for license fee for investigative assistants. (H/S: adopted)

SUMMARY: Retail sellers of table wines allowed free choice in selection of distributors rather than being required to deal exclusively with wholesaler assigned the territory where retailer is located.

COMMITTEE AMENDMENT "A" (H-159): Allows retailer to buy wine from wholesaler other than the wholesaler assigned that territory only if the retailer travels to the wholesaler's warehouse and transports the products himself (m. rep) (H/S: adopted)
