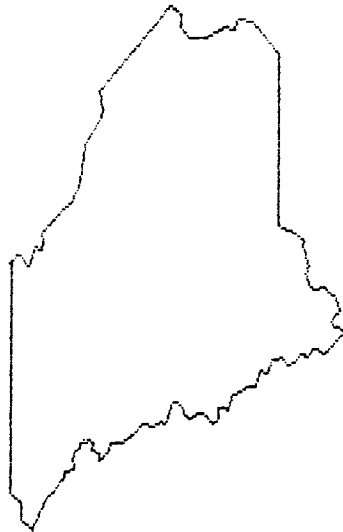

974 AN ACT TO CREATE A STATE CIVIL Trafton LV/WD
RIGHTS LAW

SUMMARY: Sought to establish a State remedy for violations of civil rights. It included a civil action in which an injunction, damages, or other civil remedy could have been sought, and a criminal action based on intentional or knowing use of force in trying to prevent someone from exercising his civil rights.

989 AN ACT RELATING TO SENTENCES FOR Higgins,L. ONTP
OPERATING UNDER THE INFLUENCE

SUMMARY: Sought to require sentences of incarceration imposed for drunk driving to be served without undue delay and without regard to the convenience of the defendant. The defendant would have been required to show the court a compelling need to have his 48 hour sentence schedule delayed or modified.

992 RESOLVE, TO REIMBURSE DAVID JAMES Martin,J. HELD IN COMMITTEE
MCDANIEL FOR DAMAGES SUFFERED AS A
RESULT OF WRONGFUL IMPRISONMENT

SUMMARY: Sought the appropriation of \$100,000 to Mr. McDaniel. The bill is being held over so that his case may be looked into further and so that the possibility of creating a mechanism in Maine for addressing claims based on imprisonment of innocent persons, without resort to the Legislature, may be studied.

1016 AN ACT TO ESTABLISH NEW SELECTION Pearson PL 1983, c. 492
PROCEDURES FOR THE MAINE INDIAN
TRIBAL-STATE COMMISSION CHAIRMAN-
SHIP

SUMMARY: Opens eligibility for chairmanship of the Maine Indian Tribal State Commission to all Maine residents, not just retired Judges. Requires the Governor to consult with the Governor of the Penobscot Nation and the Passamaquoddy Tribe prior to appointing an interim chairman, when an interim chairman is necessary. (The Penobscot Nation and the Passamaquoddy Tribe have approved this legislation).

1017 AN ACT RELATING TO THE INVESTMENT Baldacci PL 1983, c. 266
OF FUNDS IN LITIGATION

SUMMARY: Permits the court, upon petition, to have funds in litigation, which were deposited with the clerk of courts in an appeal from a State Claims Board decision on just compensation for property taken, to be invested during the pendance of the appeal in a high interest account such as a certificate of deposit.
