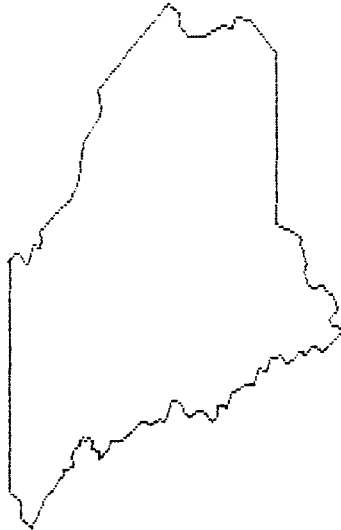

SUMMARY: School breakfast programs are presently optional. The bill would have required schools with more than a certain percentage of children from low income families to participate in the breakfast program.

SUMMARY: The bill was withdrawn because the Governor is planning a Blaine House Conference on labor training.

1131 AN ACT TO REVISE THE TRUANCY LAW Thompson LV/WD

SUMMARY: The bill provides for the superintendent to hold a meeting between the parents and teachers before taking the matter to the school board. It allows the court to require the parents to perform community service in addition to or in lieu of a fine. It reduces fine for reducing or harboring a truant from \$500 to \$250 but makes the fine mandatory.
