**1061** AN ACT TO CREATE AN EMERGENCY PETROLEUM RESERVE FOR THE STATE McGowan LV/WD

**SUMMARY:** This bill represents an updating of Maine law to reflect changes in the Council of State Government's Model Radiation Act that are appropriate for the administration of an adequate state radiation protection program. The Department of Human Services is designated as the Radiation Control Agency and is responsible for coordinating radiation activities.
