SUMMARY: This Act requires the Commissioner to publish the areas, with a shortened open season on deer, by June 1st each year rather than September 1st.

SUMMARY: This Act prohibits the open season on hunting partridge from extending beyond November 30th in any calendar year, except when the season has been closed by proclamation of the Governor. In that case it may be extended the number of days closed.
