SUMMARY: Provides for temporary licenses by nonresidents for practice of relief veterinary service; removes requirement for full board attendance for adjudicatory proceedings.

SUMMARY: Requires objective written examinations for licensure of veterinarians; provides for reciprocal licensing without examination.

SUMMARY: Provides for practice by nonresidents of relief veterinary service under a temporary license; new draft removes provisions regarding presiding officers which are governed by APA.

SUMMARY: Increases fees for several agencies within the Department of Business Regulation, and in many cases specifies a maximum fee only, with actual fees to be determined by rule of the agency; applies to Bureau of Consumer Credit Protection, Electricians' Examining Board, Arborist Examining Board, Oil and Solid Fuel Board, Board of Examiners in Physical Therapy, Board of Examiners of Social Worker Registration and Board of Commercial Driver Education.
