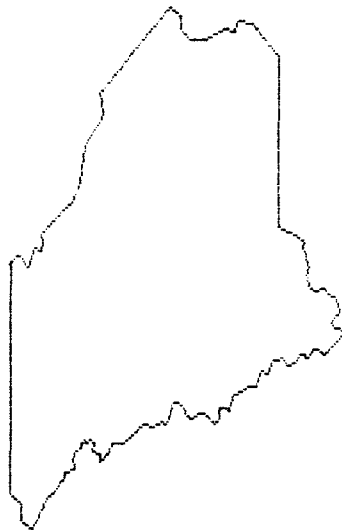

| | SUMMARY: Incorporated into LD 1378 (PL 94) which combined the revenue bill with the allocations bill reported out by the Transportation Committee. The revenue portion of LD 1378 raised the gas tax from 9 cents to 14 cents, made adjustments in registration fees for some vehicles, provided for mirror reciprocity, established a suppliers law to change taxation of special fuel from the retail to wholesale level like gasoline. Suppliers law sunsets July 1, 1985 unless extended. Provided for refund of gas tax for political subdivisions of the state. | | |
