SUMMARY: Amends the Standard Valuation and Standard Nonforfeiture Laws to conform to recommended revisions by the National Association of Insurance Commissioners (NAIC) in 1980 and since enacted in 75% of other states.

COMMITTEE AMENDMENT "A" (H-198): Makes a number of technical corrections in the bill. (ADOPTED)

SUMMARY: Removes requirement of securing cargo insurance for motor vehicles carrying unfinished wood products.

COMMITTEE AMENDMENT "A" (H-113): Adds EMERGENCY and changes reference from "unfinished wood products" to "logs or pulpwood." (ADOPTED)

102	AN ACT TO INCREASE THE TAX ON FIRE INSURANCE PREMIUMS (EMERGENCY)	CARRIER	OTPN(821)

SUMMARY: Increases the tax on fire insurance premiums from 3/4 of 1% to .95 of 1%. Taxes are currently dedicated to the Fire Marshal's office.

SUMMARY: Increases fire insurance premium tax from 3/4 of 1% to .95 of 1%; changes method of payment to require quarterly estimated tax payments based on current year; further dedicates 10.5% of funds to Fire Services Training program administered by Department of Educational and Cultural Services.
